**ZHYTOMYR POLYTECHNIC STATE UNIVERSITY ADMISSION RULES
FOR FOREIGNERS AND PERSONS WITHOUT CITIZENSHIP
in 2019/20 academic year**

General Remarks

1. Zhytomyr Polytechnic State University educational activity is carried out in accordance with the license of the Ministry of Education and Science of Ukraine (series AE No. 636494 from 19.06.2015; license validity until 01.07.2016-01.07.2025), the Act of approval of the list of specialties in accordance to which applicants are trained.

2. Admission rules were constituted by Zhytomyr Polytechnic State University Admission Committee in accordance with the legislation of Ukraine and the Conditions of admission to higher education institutions of Ukraine in 2019, approved by the order of the Ministry of Education and Science of Ukraine No. 1096 from October 11, 2018 and registered with the Ministry of Justice of Ukraine, December 21, 2018 №1456 / 32908. Admission rules may be applied throughout the calendar year.

3. Zhytomyr Polytechnic State University provides admission according to degrees, specialties, and forms of training in accordance with the license and within the licensed volume. Foreigners who come to Ukraine with study purposes may be admitted to Zhytomyr Polytechnic State University for accredited educational programs (specialties) (see Table 1).

4. Foreigners and stateless persons who reside legally on the territory of Ukraine may be admitted to Zhytomyr Polytechnic State University if they have an appropriate educational level, and express a desire to get higher education.

Foreigners and stateless persons residing in Ukraine, persons granted refugee status in Ukraine, persons who need additional or temporary protection, and persons granted foreign legal status as well as persons who are legally resident in Ukraine may get higher education along with the citizens of Ukraine. Higher education for these categories of persons at the expense of the state budget is carried out within the limits set by the Cabinet of Ministers of Ukraine.

All persons getting higher education at Zhytomyr Polytechnic State University have equal rights and responsibilities.

5. Admission to Zhytomyr Polytechnic State University for all educational degrees is carried out on a competitive basis, regardless of education funding sources.

6. Hostel accommodation for applicants during entrance exams are guaranteed. Living conditions meet all sanitary and hygienic standards.

7. Foreigners and stateless persons admission to Zhytomyr Polytechnic State University is carried out in accordance with the Laws of Ukraine “On higher education”, “On the legal status of foreigners and stateless persons”, “On foreign Ukrainians”, “On refugees and persons in need of additional or temporary protection”, by Decree of the President of Ukraine of June 3, 1994 No. 271, “On measures for the development of economic cooperation of the oblasts of Ukraine with the adjacent regions of the Republic of Belarus and administrative-territorial units of the Republic of Moldova”, by Decree of the Cabinet of Ministers of Ukraine of February 26, 1993 No. 136, “On Education of Foreign Citizens in Ukraine” of September 11, 2013 No. 684, “Some Issues of the Recruitment Kit for Foreigners and Stateless Persons”, by order of the Ministry of Education and Science of Ukraine of November 1, 2013 No. 1541, “Some Issues of Organization of Recruitment and Training (Internship) of Foreigners and Stateless Persons”, registered at the

Ministry of Justice of Ukraine of November 25, 2013 under No. 2004/24536 (as amended by the Ministry of Education and Science of Ukraine Order of December 11, 2015 No. 1272).

8. Foreigners and stateless persons (hereinafter – foreigners) may obtain higher education at the expense of legal persons, unless otherwise provided by international treaties of Ukraine, the consent of which is provided by the Verkhovna Rada of Ukraine, legislation or agreements between higher education institutions on international academic mobility.

9. Foreign applicants admission at the expense of natural persons (legal entities) may be carried out at Zhytomyr Polytechnic State University:

- 1) twice a year, before and at the beginning of academic semesters (but not later than November, 1 and March, 1 respectively) for obtaining bachelor and master degrees;
- 2) during the year for postgraduate and doctoral studies.

10. Zhytomyr Polytechnic State University admission committee calculates entrant's points / grades on the basis of the document of previous education and establishes entry minimum for general subjects entrance test.

11. Foreigners admission is based on entrance examinations in certain subjects as well as the language of study and on the basis of academic rights to continue education provided by the document on the level of education obtained in the country of origin, and taking into account the achievement points that give the right to continue education at the next higher education level in accordance with the law of the country which issued the educational attainment document.

12. All categories of foreigners may be admitted to Zhytomyr Polytechnic State University on the basis of admission orders. Confirmation may be generated in the Unified database.

13. Foreigners who are awarded state scholarships under international treaties, general government programs and other international obligations of Ukraine are admitted within the established quotas for foreigners on the basis of directions of the Ministry of Education and Science of Ukraine.

14. Foreigners who come to Ukraine to participate in academic mobility programs or to pursue higher education in educational programs agreed between Ukrainian and foreign higher education institutions may be admitted on the basis of obligations of the higher education institution.

15. Foreign Ukrainians who are legally resident in Ukraine and whose status is certified by a certificate of a foreign Ukrainian may be admitted to Zhytomyr Polytechnic State University with the same rights for education as the citizens of Ukraine, with the exceptions established by the Constitution of Ukraine, laws of Ukraine or international treaties, the consent of which was provided by the Verkhovna Rada of Ukraine.

16. Foreign Ukrainians, whose status is certified by a foreign Ukrainian certificate, may be admitted within the established quotas for foreigners on the basis of the interview in certain subjects stated in the Admission Rules.
